APPLICANT CRITERIA

Applicants must be Vermont residents. All work must be original, skillfully rendered and without technical fault, whether one-of-a-kind or limited edition. **Only items shown in application and/or comparable work by that artisan may be sold at the show. Each artisan must have substantial hands-on involvement in the work and must be present at the show with his/her work.** Fine art, food products, toiletries, and dried / silk flower arrangements are not eligible.

BOOTH FEES - Booth spaces in the Playhouse are irregular; cost is based on location and size.

STREET LEVEL: \$400-\$450

LOWER LEVEL: \$400

UPPER LEVEL: \$300 - \$425

DO NOT SEND BOOTH FEE WITH THE APPLICATION

APPLICATION PROCEDURE: Applicants must submit **five (5) photos** which accurately represent their work.

Descriptions should note the techniques and materials that assure quality and represent originality. Please also indicate a price range for your work.. Photos can be **JPEG (preferred), TIF or PDF** submitted by **CD or email.**

- ≡ **New applicants** should provide a 6th **picture, drawing or slide of their display** with dimensions to assist us in placing your system in our irregular spaces, if you are accepted.
